W-1. Approval of Employment Agreement - Kirk D. Medina

The Experience Modifier has been increased to 1.55, which will result in a significant increase in the District's premium in 2024. Rabe also reported that, in response to a question from Director Dent, he had reviewed a few of the District's tower site leases and did not find any language in the agreements that concerned him.

Director Willcox reported that the Safety Committee met on Wednesday August 9, 2023. The Committee discussed the need for all employees to receive training on customer service and dealing with customers.
