W-1. Adopting Official Meeting Place/Time and Posting Places – Action Item (Medina)

The Hoelting & Company provided a letter of engagement to the district to confirm the services to be provided to conduct the 2024 audit for the Water District.

W-3. Approval of Resolution No. 2025-01 – Action Item (Medina)

The Board must appoint a Designated Election Official (DEO) for the May 2025 Board of Directors Election. The district manager is recommending Shana Greer be appointed as the DEO.

Recommended motion...." To adopt Resolution 2025-01 to appoint Shana Greer as the Designated Election Official (DOE) for the May 6, 2025, Election."

W-4. Approval of Resolution No. 2025-02 – Action Item (Medina)

The regular election of the eligible electors of the Water District shall be held on May 6, 2025, between the hours of 7:00 A.M. and 7:00 P.M. in accordance with Uniform Election Code. At this time, two (2) Directors will be elected to serve a four-year (4) term.

Forsgren has proposed an agreement to provide engineering support for the design, bidding and construction phases of the 2.5 million gallon water tank recoating project. The district has received a grant to cover one half of the costs of this project.
