S-2. <u>2024 Sewer Rate Increase</u> – Action Item (Colgrove)

A public hearing was held on December 6, 2023, where the public had an opportunity to comment on the proposed 2024 Sanitation District rates and fees. After carefully evaluating the existing sewer rate structure, the Board has determined that a 3% rate increase, as presented in the proposed rate table, is needed to provide adequate funding for the Sanitation District in 2024. This increase will raise the average sewer bill by roughly \$1 per month and it will allow infrastructure improvements to continue as needed.

Suggested Motion "... to approve Resolution No. 2024-001 increasing the sewer rates and fees as described in the resolution, effective February 1, 2024."

S-3. 2024 Budget Updates - Informational Item (Medina)
